Background:

The Listing Regulations require listed companies to conduct familiarisation for the independent Directors to familiarise them with the Company including their roles, rights and responsibility in the Company, nature of industry in which the company operates, business model of the Company, etc. Dynamatic Technologies limited facilitates the members of its Board to familiarise themselves with the industry and its operations.

Dynamatic Technologies Limited - Familiarization programme for Independent Directors

1. Prior to joining the Board, an Independent Director is provided with an induction programme to enable the director to familiarize himself / herself with the business and operations of the Company which include the Company's Corporate Profile, its Mission, Vision and Values Statement, Organizational structure, the Company's history and milestones, latest Annual Report, Code of Conduct applicable to Directors, the 'Dynamatic Code of Conduct for Prevention of Insider Trading along with a summary on do's and don'ts pertaining to Insider Trading issues.

The programme generally covers the following:

- Initial Meeting with the Managing Director and CEO, the Executive Directors.
- Meeting with the Heads of Marketing, Sales and Distribution, Human Resource, Chief Financial Officer, Legal and Secretarial, Heads of Divisions at Aerospace & Hydraulics, Bangalore; Dynamatic-Oldland Aerospace, UK; Eisenwerk Erla GmbH, Germany and Dynamatic Manufacturing Limited, Bangalore.
- These meetings will cover detailed functional aspects of the Business coupled with visit to Aerospace and Hydraulics Factories and manufacturing locations at Bangalore.
- 2. Post Joining the Board

At quarterly board meetings held to consider financial results, a detailed presentation is circulated to all directors which cover the following:

- Financial highlights including legal entity wise financials and region wise financials including performance against the budgets
- Operational Highlights -Unit/ Division wise
- Forex and Treasury Highlights
- Corporate Social Responsibility initiatives of the Company



- Business Strategies
- Operational highlights of Subsidiary Companies
- CSR Activities undertaken by the Company
- 3. In addition to the above, a detailed presentation is made by the Managing Director & CEO, and CFO, Divisional/Unit Heads at the Board meeting covering the above areas.
- 4. Members of the Audit Committee and Board travel to different locations once a year wherein they are presented with the business and operations of the region in a detailed manner.
- 5. In addition to the above, a detailed presentation on the Company's operations -Consolidated and Standalone is presented quarterly to the Board which covers all Departments/Units. Further the Independent Directors are familiarized with the Risk Management, HR processes, CSR, Safety and Sustainability initiatives of the Company at their respective committee meetings of which they are members.
- 6. Specific training provided to directors as and when requested.
